The minimum entry requirement for admission to a Bachelor Degree Program stated in the SINU Academic Policy is given as follows:

Shall be a pass in the Solomon Island's Year 13 examinations (Form 7), or its equivalent, with at least 50% in subjects designated in the relevant programme regulations.

Successful completion of a Higher Education Certificate or a Higher Education Diploma also meets the entry requirement criteria for the Bachelor degree.

Recognition would be granted to applicants who do not meet the continuous progression requirement, but who are able to demonstrate their ability to succeed in the higher education Programme at Level 5 on the basis of maturity, work experience, or prior learning.

Students may also be provisionally enrolled in the Bachelor degree Programme if they have successfully completed Year 12 Examinations, or equivalent, with at least 50% in subjects designated in the relevant Programme regulations.

The Bachelor of Environmental Studies will be offered on a semester basis with three (3 core) units & two (2) electives offered per semester for year 2 & 3, except for Year 1, Semester 1 which offers three (3) core & two (2) generic units and Semester 2; that offered four (4) core units and One(1) SINU generic unit. A total of thirty (30) units offered under the program covering a total of six (6) semesters or 3 years. Students are required to complete only twenty six (26) units before qualified to be conferred with the degree. Refer to detail structure on the next page. This is a program that evolves from the Diploma, with the expectation that candidates would have had good background knowledge in environmental sciences, or had graduated with a certificate in environmental studies. This Program aims to equip students with skills and practical knowledge that will empower learners to become environmental educators and advocators in their communities and Solomon Islands. It will help students to better utilize and manage their natural resources towards environmental sustainability and benefits. Learners are expected to develop, encourage networking, and engage in intelligent public disclosures on matters of national and international interests.

Admission Requirement

The target students to undertake the BES program are:

- Year 13 (Form 7) high school leavers, SINU UPCIV Graduates. Minimum Form 7 with a passes in math, Science, English and Social Sciences subjects.
- F6, F5 or mature aged candidates with 5 or more years of experience in the relevant fields will also be considered.
- Graduates from Diploma in Environmental Studies can come direct into the Program and those with Certificate in Environmental Studies with a GPA of 3.0 and above can also be considered
- Mature candidates These are applicants who are over the age of 23 years and are defined as mature students. The public servants and private organizations employees who wish to expand and broaden their knowledge and would like to pursue further studies in the area of Environmental Studies with 5 years or more work experience.

CERTIFICATE OF ENVIRONMENTAL STUDIES (CES) Description of the Program

This is a two-semester program with a total of eight (8) units. Students are required to attain a total of 120 credit points to fulfil the requirements of the program. The sequencing of the program still resembles the older version of the two-year certificate program which was phased out in 2017, but with more emphasis on equipping students with knowledge and skills that they can apply in their communities or as environmental advocators. This is a standalone certificate, which means that it is not stair-cased into the diploma program. However, for those wishing to enroll in the diploma program, especially Form 5 school leavers, it is a requirement and highly desirable that they graduate with a certificate in environmental studies. The reduction in the number of units does not affect the knowledge base or the practical skills expected of our students. It introduces a clear demarcation of scope and content in each unit and allows this shift to be shared between the certificate and the diploma program.
